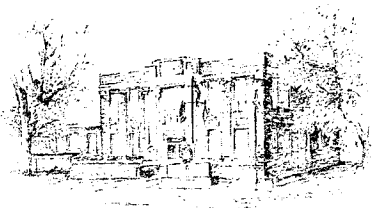

Motion #11 by Brawner, 2nd by B. King to ratify the nomination for Justin Dyer and the job title to be changed to Animal Control Officer.

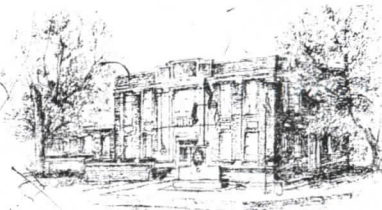
